5. Adjacent Ways and Bond Expenditure for the Transportation Parking Lot

Ms. Biggerstaff called on the public for comment:

- Rosanna Jumbo: Said there was an error in the proposal and that the total project cost is approximately \$400,000, not \$617,048 as presented.
- Bruce Johnson: Asked Board Members their definition of ingress and egress. He said the point of entry and exit on a one-way road is the ingress and egress not the route in between.

Mr. Kulpinski asked if legal counsel had been consulted yet about the use of the adjacent ways funds. Dr. Garland said Administration is asking approval to proceed with the project and the determination of legal counsel will help determine how much will be paid with adjacent ways funds and how much will be paid with bond funds.

Mr. Kulpinski moved to approve Phase 1 of resurfacing the front half of the parking lot at the Transportation Department, contingent upon legal counsel's interpretation of ingress and egress making sure the apportionment is legal, fair and equitable with a report on the funding to be made at a future public meeting. Mr. Vasquez seconded; motion carried.

Mr. Kulpinski moved to approve and adopt the Superintendent's Contract and Performance Pay Plan. Mr. Vasquez seconded; motion carried.
