1. Workforce Development Training Center Update

Ms. Hickman introduced Jac Heiss, Coconino Association for Vocations, Industry and Technology, and John Cardani, Coconino Community College Executive Director of Community and Corporate Learning. Ms. Hickman, Mr. Heiss and Mr. Cardani provided an overview of the 2012 update to the Northern Arizona Workforce Training Center Demand Study that was originally conducted in Summer 2009.

2. Superintendent's Report

Ms. Hickman reviewed her written report. She said that the 47th day student count was up 163 over last year. Mr. Kulpinski would like centralized tracking of where new students are coming from.

3. Calendar Update

Ms. Hickman reviewed the results of the online survey and comments from the public forums regarding the possible change from a traditional calendar to a more balanced calendar. She also reviewed some of the challenges and advantages to changing to a balanced calendar. Ms. Biggerstaff suggested that only four snow day make-ups be scheduled for next year instead of six and that school begin August 12 instead of August 8 as shown on the draft calendar. The draft calendar will be discussed in the Interest Based Strategies meeting tomorrow.

Richard Henn, Fit Kids of Arizona Director, provided a PowerPoint presentation updating the Board on the Fit Kids program that is currently taking place in all ten elementary schools.

Mr. Kulpinski moved to approve the intergovernmental agreement with Coconino Coalition for Children and Youth and the City of Flagstaff for enrichment and academic support for children and youth during afterschool programs. Ms. Biggerstaff seconded; motion carried.

Ms. Biggerstaff moved to approve Board and Administration attendance at the Arizona School Boards Association-Arizona School Administrators annual conference, which will be held December 12-14, 2012 in Phoenix. Mr. Vasquez seconded; motion carried.

13. Governing Board Self Evaluation

Ms. Ells said that the Board is not required by statute to perform an annual self-evaluation; however Board Policy currently requires one. While she feels there could be value to the Board, District and Superintendent to have that discussion, Ms. Ells suggested waiting until next year since there will be one to three new Board Members in January. Since the Board regularly addresses many items that would be covered in its self-evaluation, Ms. Hickman suggested that the Board revise or remove this policy. It was agreed that the policy should remain but be revised to indicate that the Board *may* have an annual evaluation and to not specify a date. The revised policy will come to the Board for approval at the November 13 meeting.
